



Grace Project 180 Volunteer Release and Waiver of Liability

This Release and Waiver of Liability (“Release”) executed on this ____ day of _____, 2010.
By _____ (“Volunteer”) in favor of GRACE PRESBYTERIAN CHURCH OF HOUSTON, TEXAS;
and HOUSTON INDEPENDENT SCHOOL DISTRICT, together with its pastors, officers, employees, agents, and their successors
and assigns (collectively, “the Released Parties”). The Volunteer, where indicated below, shall include his or her children under 18
years of age who are individually listed.

I, the Volunteer, desire to work as a volunteer in connection with activities scheduled to be undertaken by the Released Parties on
March 26 and 27, 2010, whether such volunteer work is performed on, before or after such dates (“the Grace Project 180”). Such
work includes but is not limited to: painting, renovations, carpentry, landscaping and other related and similar activities; assisting
with childrens’ activities; disseminating supplies; and serving food and other refreshments, at the Paul Revere Middle School and
Walnut Bend Elementary School. I hereby freely and voluntarily, without duress, execute this Release under the following terms:

I hereby release and forever discharge and hold harmless the Released Parties from any and all liability, claims and demands of
whatever kind or nature, which arise or may hereafter arise from my work in connection with or related to the Grace Project 180.

I understand and acknowledge that this Release discharges the Released Parties from any liability or claim that I may have against
them with respect to any bodily injury, personal injury, illness, death or property damage that may result from my participation in
the Grace Project 180. I also understand that the Released Parties do not assume any responsibility for or obligation to provide
financial assistance or other assistance, including but not limited to medical, health, or disability insurance, in the event of injury,
illness, death or property damage.

I hereby authorize the Release Parties to provide any first-aid treatment or other medical services that may be required in connection
with the volunteer work performed, and hereby release and forever discharge the Released Parties from any claim whatsoever which
arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an
emergency during the time that I volunteer for activities related to the Grace Project 180.

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that
this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. I agree that in the event that any
clause or provision of this Release shall be determined to be invalid, any invalidity shall not otherwise affect the remaining
provisions of this Release, and a Court shall have the authority to reform any invalid clause or provision to carry out the intent of
the parties.
